1. USACE – Daniel Cottrell / Tamara Cameron – presented report. Will provide written version for publication.
  2. SPPA –Ava Kenney presented. Rail spur going in at the Alter leased property in the south port. Alter also building a fertilizer facility going in within a mile of that facility. 4800 linear feet of rail going in, hoping to get a unit train back there. General contractor is Bolander and they are in the process of moving soil right now, with the hope of being substantially complete by the end of this year. That work is being done via a PDA grant from the MnDOT, and another project getting underway next spring – a barge receiving facility. This project will go out to bid this winter. Linda Williams reported on the road being overlaid at Red Rock. As of yesterday the road was completely milled and being patched, final layer to go down next week with a completion slated for the end of October.
  3. LMRWD – Linda Loomis – working with MNDOT on the upgrade of Hwy 13 at the Savage port. There is a proposed temporary road closure that they are working to facilitate this closure.
  4. MNDOT – Patrick Phenow – MnDOT just submit their final capital budget request to the governor. Their standard request is 10,000,000, and the ports submit their request of 28,000,000. It was suggested by the commissioner that the requests be more closely aligned, so the MnDOT request was increased to 28,000,000.
